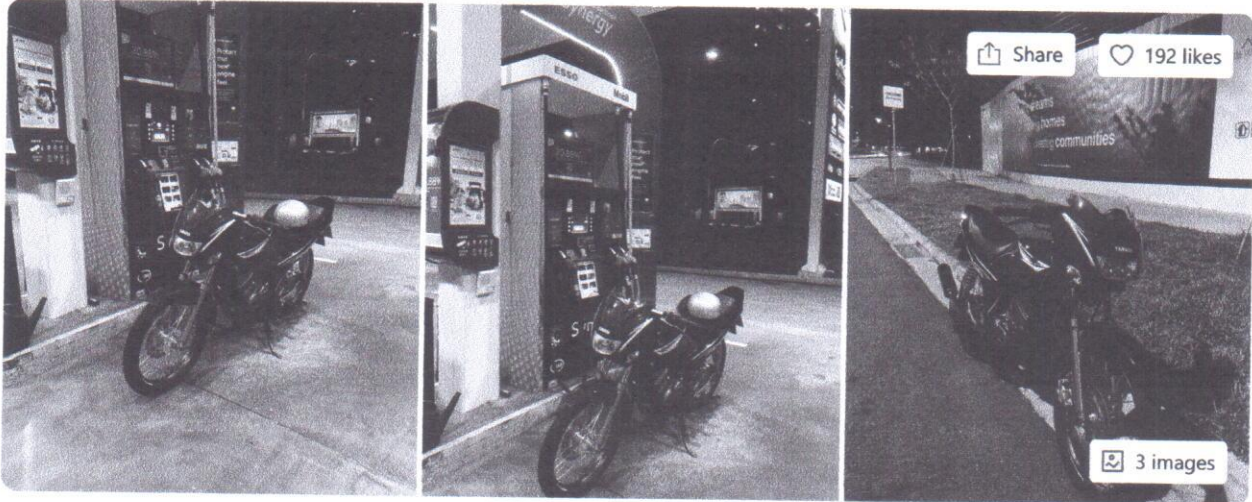

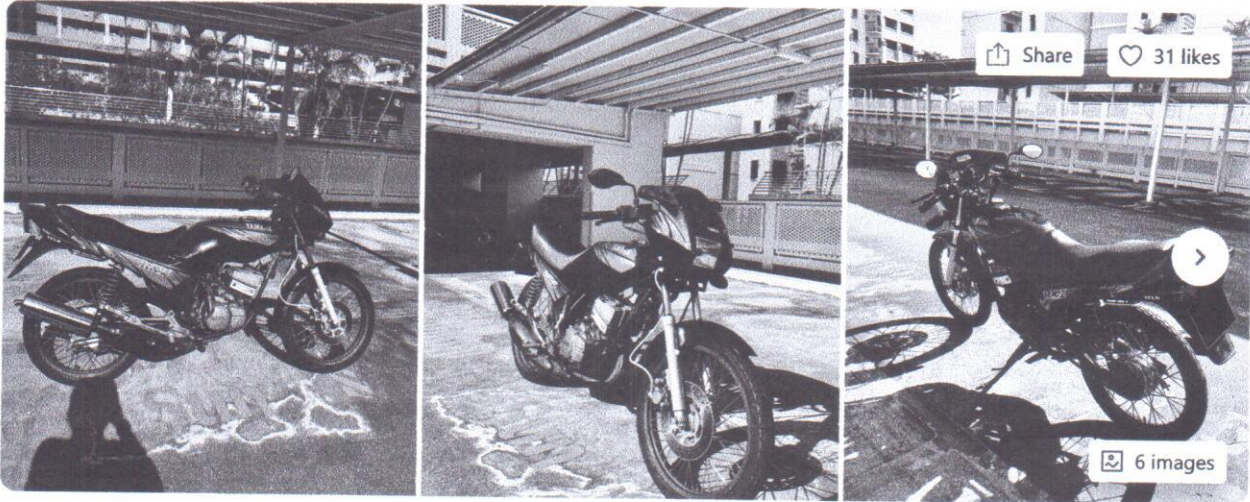

**SERIOUS TURNED FATAL ROAD TRAFFIC ACCIDENT ON 29 JUNE 2020 (MONDAY) AT ABOUT 5.58 AM ALONG UPPER SERANGOON ROAD BY UPPER SERANGOON CRESCENT INVOLVING A MOTORCYCLE; FS 1406 K, AND A TAXI; SHB 585 Z.**

I refer to the serious turned fatal road traffic accident involving the late Mr Qusyairi Nor Hazim Bin Nor Haizat.

2. We share the grief and anguish of your recent bereavement and sincerely hope that you and your family have adjusted to the loss of a loved one.
3. The driver of taxi, SHB 585 Z, has pleaded guilty in the State Court No. 4B on 6 July 2021 to the offence of Careless Driving Causing Death under Section 65(1)(b) of the Road Traffic Act Chapter 276, punishable under Section 65(2)(a) of the same Act.
4. He was sentenced to a total of 7-months' imprisonment with effect from 24 May 2021 and disqualified from holding or obtaining all classes of driving licence for a period of 8 years with effect from date of release.

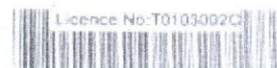

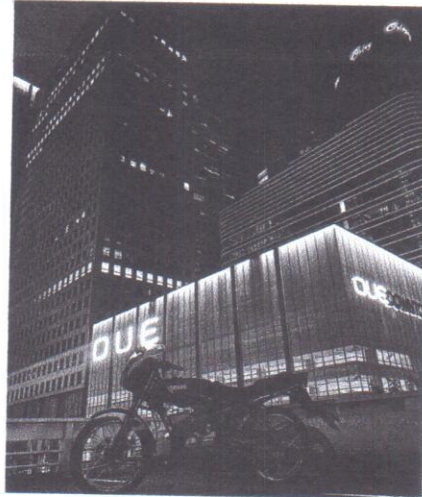
