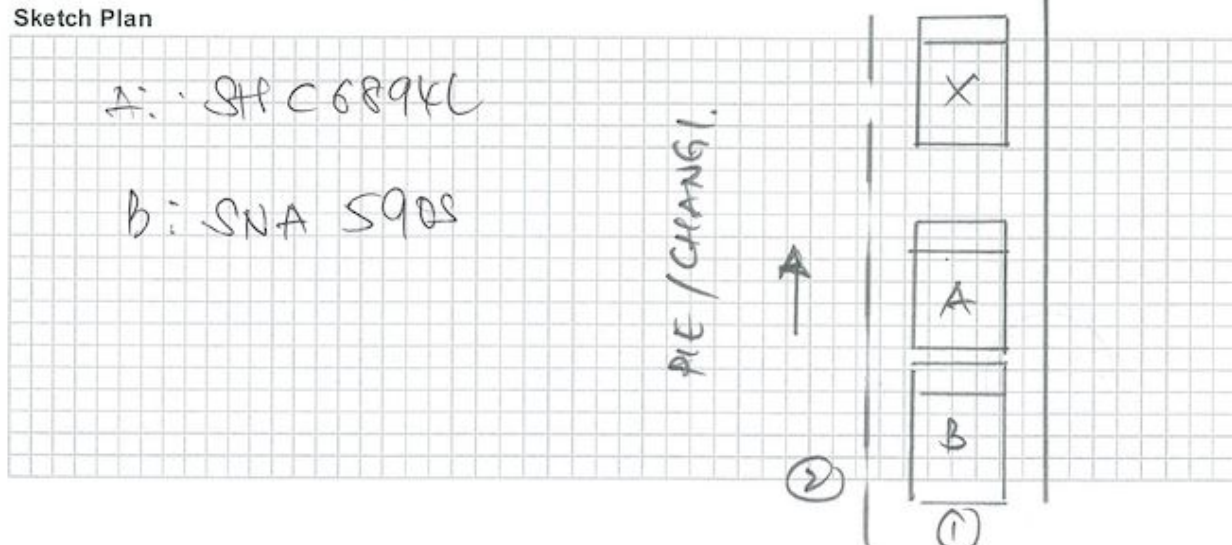

Describe Circumstances of the Accident.

ON 10/08/2021 @1430HRS, I WAS DRIVING MY TAXI (**SHC 6894 L**), TRAVELLING ALONG PIE – CHANGI WITH 2 PASSENGERS ONBOARD, ON LANE 1.

I SLOWED DOWN MY TAXI TO A COMPLETE STOP AS VEHICLES AHEAD OF ME STOPPED.

WHILE STATIONARY, SUDDENLY I FELT AN IMPACT FROM THE REAR.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B (**SNA 590 S** – TOYOTA) WHICH WAS BEHIND ME, HAD COLLIDED ONTO THE REAR OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE REAR PORTION & VEHICLE B HAD DAMAGES ON THE FRONT PORTION.

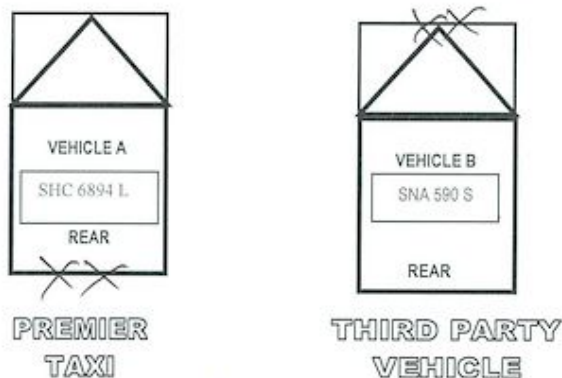
