I am lodging this report for record purposes and investigation on my end.

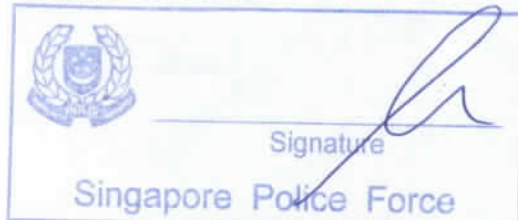
