**Brief Details.**

On 02 August 2021 at around 7.30am, I was riding my motorcycle (Yamaha Y15ZR, Registration Plate: JSC 3864) along KJE towards Tuas. I am unable to recall the expressway had how many lanes, but I recall that I was riding on the middle lane. There was a blue-coloured car on my right lane that was driving slightly ahead of me. As I was about to ride past the car, the car suddenly cut into my lane and I was unable to stop in time. As a result, the car sideswiped onto my motorcycle, which caused me to lose control of my motorcycle and fall off. I am unable to recall if the car had used his signal lights prior to changing lane.

I blacked out for a while and only realised later that Ambulance had arrived and paramedics were making a check on me. Subsequently, I was conveyed to Khoo Teck Puat Hospital. On 03 August 2021, I was discharged from the hospital. I received a call from Traffic Police who asked me to lodge a Traffic Accident Report. I was told that my motorcycle is with Traffic Police currently.

According to the primary diagnosis, I sustained a fracture - RTA complicated by undisplaced fracture of right temporal bone and anterior wall of right external auditory canal. I also sustained cuts and abrasions on my arms. I was then given 12 days Hospitalisation Leave to rest at home.
