1. We act for Mr Lee Bon Leong.
2. We refer to the above-captioned matter and your letter to our client dated 19 August 2021, undersigned by one Mr Jasper Chua.
3. We understand that the said Mr Jasper Chua, with whom our client had been liaising with, has since left your company. Kindly ensure that this letter is directed to whomever has taken over conduct of the matter.
4. As we have been instructed by our client to review the matter, we would appreciate if your good office would provide us the following documents/information requested for herein below.
5. Our client instructs that an inspection was conducted on his motor vehicle bearing licence plate no. ER 5115R following the alleged accident on 5 August 2021 along/at Ghim Moh Road, and during which inspection one of your staff had verbally confirmed to our client that there were indeed no scratches/visible damage on our client's vehicle.
6. Our client was also provided with car camera footage from the day of the alleged accident. However, upon reviewing the same, the said footage does not show that our client's car had hit the motor vehicle bearing licence plate no. SMZ 4930Z ("SMZ 4930Z").
7. Our client is also not aware of any eyewitness accounts to corroborate the claim that it was our client's motor vehicle that had hit and caused the damage to SMZ 4930Z.
