

ON 1ST OF AUGUST 2021. AT ABOUT 11:55AM, WAS RIDING MY SCOOTER WITH REGISTRATION NUMBER, AU5154J, ALONG
ENGGOR STREET FROM PALMER ROAD. I WAS RIDING ON A MIDDLE LANE OF A 3 LANES AT 40-50KMPH, AS I WAS RIDING
ALONG ENGGOR STREET, INOTICED A RED KIA WITH REGISTRATION NO. SKT7924C STATIONARY IN BETWEEN THE
EXTREME LEFT AND MIDDLE LANE. AS I WAS PROCEEDING STRAIGHT ALONG THE MIDDLE LANE CLOSE TO THE CAR, THE
SAID CAR IMMEDIATELY SWERVE RIGHT ENCROACHING INTO MY RIGHTFUL OATH OF TRAVEL. TO AVOID THE COLLISION,
IMMEDIATELY APPLIED EMERGENCY BREAK AND SWERVED RIGHT CAUSING MY SCOOTER TO SKID FOR ABOUT 2-4

WHILE MY BIKE WAS TOWED BY TRAFFIC POLICE









On 1st of August, 2021, at about 11.55am, as I was riding my scooter with registration number, AU 5154 J, along Enggor Street from Palmer Road. I was riding on a middle lane of a 3 lanes at 40-50 kmph. As I was riding along Enggor Street, I noticed a red Kia with registration no. SKT 7924 C stationary in between the extreme left and middle lane. As I was proceeding straight along the middle lane close to the car, the said car immediately swerve right encroaching into my rightful oath of travel. To avoid the collision, I immediately applied emergency break and swerved right causing my scooter to skid for about 2-4 meters.
