Our comments and conclusion

We re-appraise the damage shown by the submitted photographs making close references to ComfortDelGro Engineering and would offer our re-appraisal as follows:

For your understanding of our re-appraisal on the parts, the full details are reflected in Annex A of this re-appraisal report.

For labour and spray painting cost, we have re-appraise downwards from \$1,880.00 to \$1,680.00. The reduction is \$200.00

For your understanding of our re-appraisal on labour/spray painting cost, the full detail are reflected in Annex B of this re-appraisal report.

In total, the repair cost has been reassessed at \$12,423.44 on part by part basis. After having considered extent of damage sustained, point of impact and scope of repairs required. We would state, in conclusion, the claim for the repairs to be considered at \$12,423.44 on a part by part basis as fair and reasonable, within a repair period of five (05) working days.

As between our adjustment of \$12,423.44 and the repair cost of \$12,623.44 by ComfortDelGro, a reduction of \$200.00 resulted.

We submit our re-appraisal report for your kind consideration and would add it was carried out to the best of our ability, knowledge and experience.
