1. We have been instructed by MSIG Insurance (Singapore) Pte Ltd to conduct defence of their insured in connection with the above suit. The suit in question relates to a road traffic accident involving motor vehicles SJL 7274Z (plaintiff) and FBJ 5105Y (defendant). This action is also a simplified civil action under Order 108 Rules of Court. Amongst other things, it means that a single joint expert (SJE) had to be appointed – either by agreement between the parties to this action or by appointment by the Court where there is no agreement between the parties.
