UPON TURNING GREEN I DROVE OFF AD SUDDENLY A VEHICLE FROM MY RIGHT COMING FROM UPP CHANGI RD EAST COLLIDED ONTO MY FRONT BUMPER. NO INJURY SUSTAINED FROM MY END. DRIVER EXCHANGED DETAILS.
