1. The owner of motor vehicle no. YM7604Y hereby authorise **Ryder Auto Pte Ltd** to commence repairs of the said vehicle forthwith. 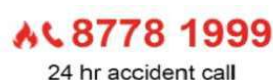

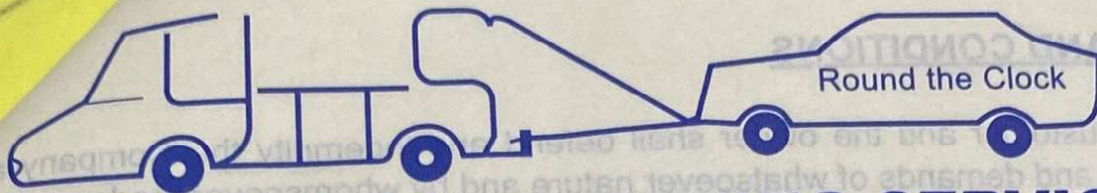
