CIRCUMSTANCES OF ACCIDENT

AT NOON, I WAS DRIVING INTO MY PARKING GARAGE AT PEBBLE BAY. I USUALLY REVERSE PARK BUT DECIDED TO GO INFRONT FIRST THIS TIME. THERE WAS A MITSUBISHI PARKED AND THERE WAS AN EMPTY SPOT NEXT TO IT. I DECIDED TO GO IN NEXT TO THE CAR AND ENDED UP COMING VERY CLOSE TO THE PARKED CAR. I TRIED TO EXTRICATE MYSELF FROM THIS SITUATION AND BUMPED INTO A PILLAR ON THE LEFT. I PANICKED AND REVERSED MY CAR OUT OF THE SITUATION AND DAMAGED THE FENDER AND THE SIDE OF THE OTHER CAR AS WELL. SO ON THE LEFT SIDE, I HIT A PILLAR IN FRONT OF ME AND THE RIGHT SIDE. I SCRATCHED THE CAR PARKED NEXT TO ME. WHEN REVERSING OUT OF IT, I ALSO ENDED UP BUMPING INTO ANOTHER PILLAR BEHIND ME.

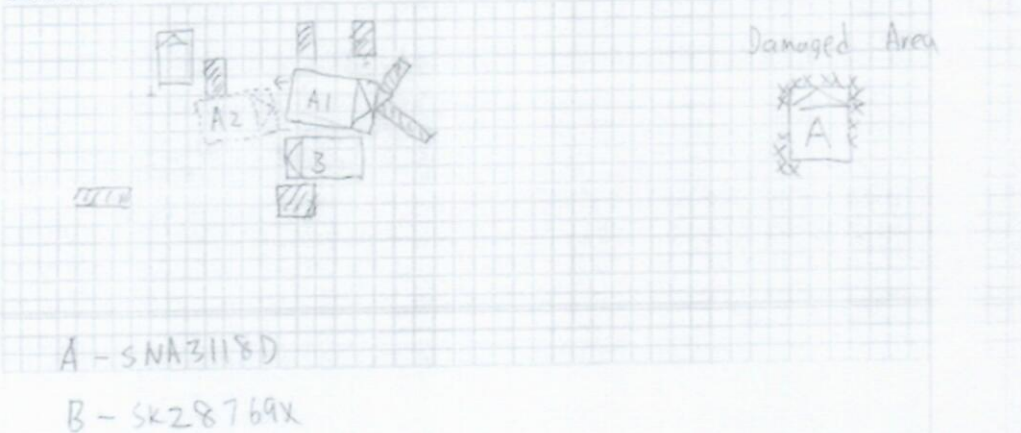

Describe Circumstances of the Accident

At noon, I was driving into my parking garage at Pebble Bay. I usually reverse park but don't look to go in first this time. There was a motorcycle parked and there was an empty spot next to it.

I decided to go in next to the car and ended up becoming coming left close to the parked car. I tried to extricate myself from this situation and bumped into a pillar on the left. I panicked and pulled reversed my car out of the situation and damaged the fender and the side of the other car as well.
