Brief Details.

On 24/02/2021 @1830 hrs, I was riding my motorbike JPK3064 along Tanjong Katong Road towards ECP. When I reached near to Domino Pizza along Tanjong Katong Road, suddenly a car from the left side of the road, turned towards the right side. I was unable to stop in time as it was too sudden. My motor bike hit onto the vehicle right front door of the driver side. I then lost consciousness. I regained consciousness on 25/02/2021 @0735 hrs, I was at Tan Tock Seng Hospital. The injuries I sustained due to the accident are; my left thigh, my left hips and left hand were operated by the doctor at TTSH, fracture on my left side of my face, pain on my left buttocks and some parts of my right leg have some abrasions. I was granted 41 days by the doctor from 24/02/2021. I am lodging this police report for insurance claim.
