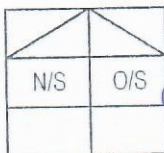

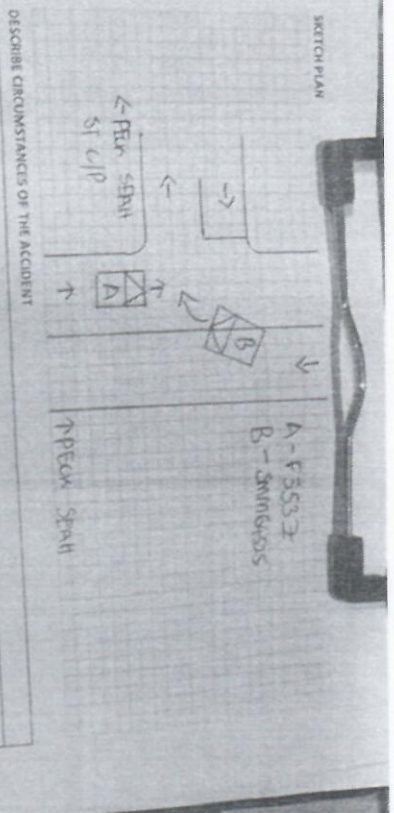

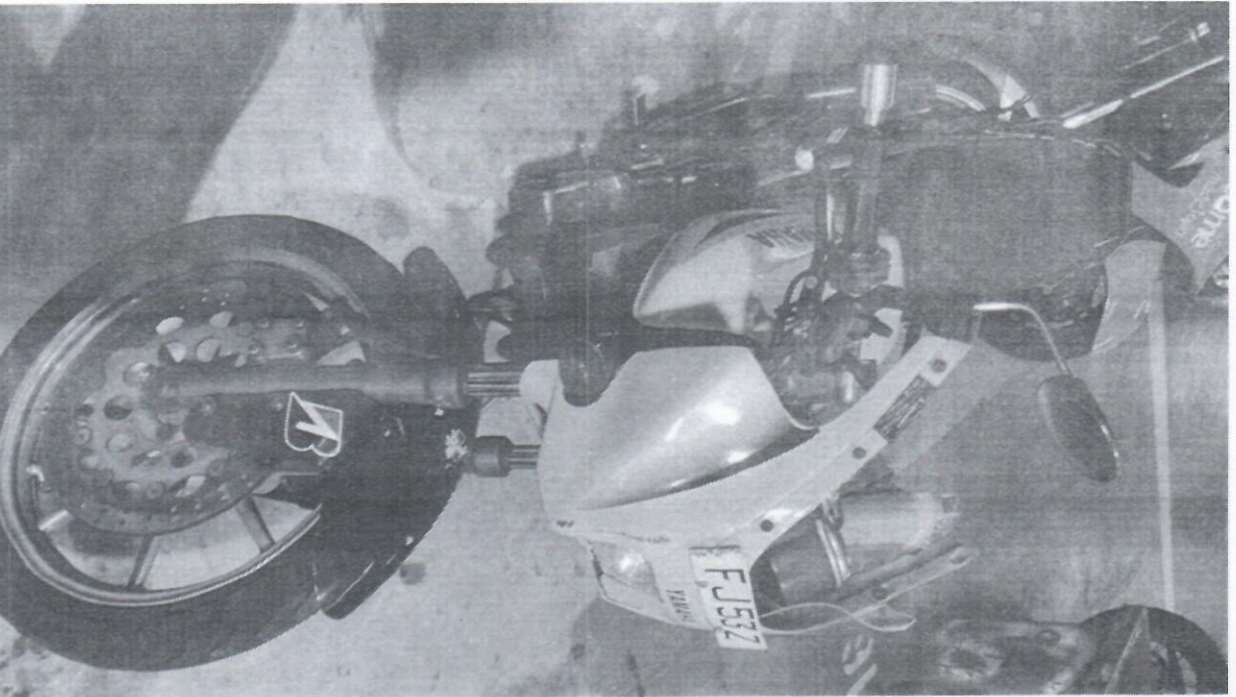

Brief Details:
On 30/09/2021 at about 1440hrs, I was riding along Pooi Seng St towards Geylang St to meet my friend. I saw one vehicle coming from the Pooi Seng St OSCP and another vehicle (White Audi S8008523D) was waiting to enter the carpark at my opposite direction. However after the vehicle entered the opposite side vehicle suddenly turn right into the carpark without turning on the signal indicator. The last vehicle then jammed brake upon seeing me riding towards him however it is too late for me to react and my motorbike has collided onto the front bumper of the said vehicle causing damages on the front part of the motorbike. I was flew out due to the impact and landed about 1 metre away from my motorbike.

Passerby from nearby shophouses assisted to call for ambulance and police. Ambulance has attended to me at scene and I was conveyed to SGH prior of TP arrival. I then contacted my friend who came to assist me as well. My friend has contacted my girlfriend who waited at scene for TP and case card was given to my girlfriend.

I was treated in SGH and I was given 5 days MC due to back ache and abrasion on both legs.

TP officer has contacted me and requested me to lodge a traffic accident report.

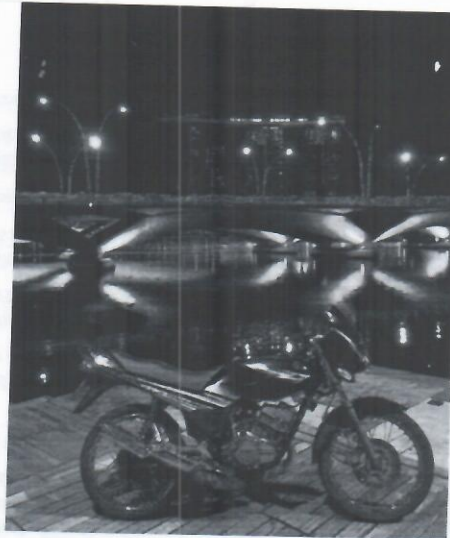
