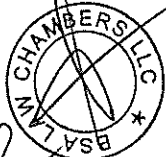

**Brief Details.**

On the 02/07/2021, at around 1.35PM.

I, Chia Wei Wen Gabriel, S8433764A , Riding FBQ1156P was travelling straight along Jalan Eunos towards PIE, as shown in the drawing. When I was travelling across the junction at Sims Avenue, I heard my Wife, who was my pillion scream, the next moment, I felt the impact of the car hitting me from the left and we fell onto the road. We landed on the left side and was dragged approximately 8 to 10 metres across the yellow box (based on the marks left behind on the road), finally stopping coming to a stop.

I only recall the car did not stop immediately and continued driving off.

As I saw the injuries sustained by my Wife, I immediately called the police for assistance. There were many passing cars who stopped to render assistance, they informed us that they managed to get the driver that hit us to stop.

Upon meeting the driver, he apologized and said that he did not even know he hit us. He only stopped because he heard a sound. He did not render any form of assistance, he only asked if we called the police, he just stood there and wait.

My wife and I was conveyed to Raffles Hospital, we suffered multiple abrasions and road rash on the left side of our bodies, mainly our left arms and legs. We were each given Hospitalization Leave of 7 days.

We only knew from our investigating officer that the vehicle's number plate was SMP58X.
