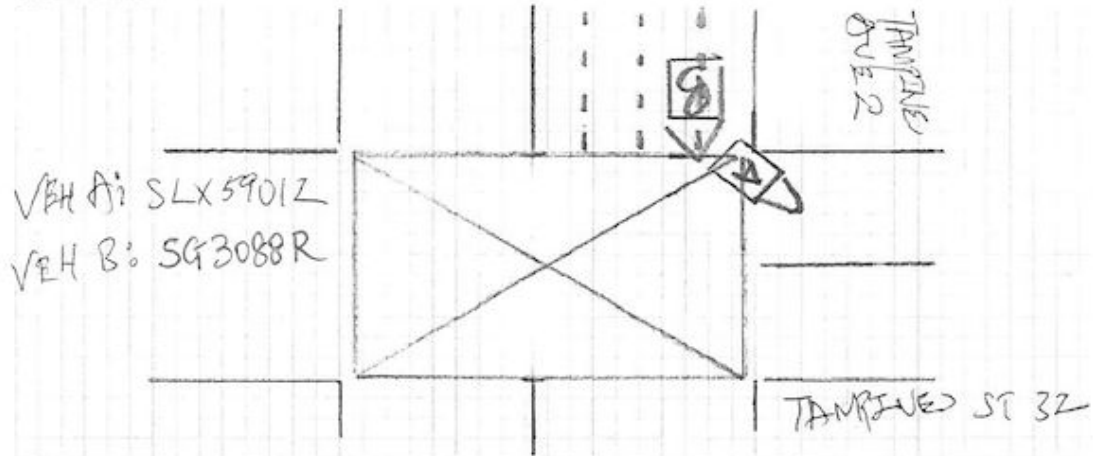

Brief Details.

On 03/09/2021 at about 1700hrs, I was driving my car (SLX5901Z) along Tampines Avenue 2. I was about to turn left into Tampines Street 32, but I came to a stop as there were pedestrian crossing the road.

While waiting for the pedestrian to cross, I then noticed a bus (Service 38) that was behind my car filtered to the next lane (right side) and started to drove off. I felt a sudden jerk and realised that the mentioned bus had knocked the rear right of my car. I horned, and noticed that the bus had slowed down, but not long after, the bus driver then drove off.

I wish to state that I do have an in-car camera installed in my car. However, only the front in-car camera is in function. Thus, I do not have the bus plate number. I wish to add on that neither my passengers nor I sustained any injury.
