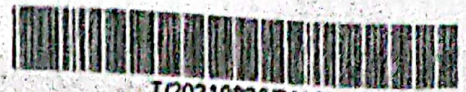

Brief Details.

On 26/08/2021 at about 0730hrs, I was riding V1) JRU6328 along Chin Bee Dr towards Jln Boon Lay. As I was approaching the junction of Quality Road, I noticed V2) YP7860H inching out from the stop line. After which, I slowed down my motorbike and to allow V2 to filter out. After slowing down, I noticed V2 was not moving thus, I sped up to continue my journey. Suddenly, V2 turned out and I was unable to stop in time. Thus, collided into the front right door of V2. I lost my balance and fell onto my right. I suffered abrasions on both my shoulders and right knee and also some swollenness on my right knee and calf area.

From the accident, V1 was badly damaged and unable to start. V2's front right door was damaged as well.

I was given MC rom 26/08/2021 to 30/08/2021.

V2's driver only provide me his contact number, 98416733 however, he did not provide me his name and particulars.

During the accident, there were a few cars behind V2 and one of the driver informed that he has a in-car camera footage of the accident however he did not gave me his contact number.
