

ON 05/09/2021 AT AROUND 1010HRS, I VEHICLE A(SLS9774Z) WAS DRIVING ALONG BUKIT BATOKWEST AVE 6 INTENDING TO TURN LEFT TO BUKIT BATOK WEST AVE 8. TRAFFIC LIGHT WAS RED THEN CHANGED TO GREEN, I PROCEEDED CAREFULLY BUT THE FRONT VEHICLE SUDDEN BRAKE RESULTING IN NOT ENOUGH TIME TO BRAKE AND I REAR ENDED VEHICLE B(SLK9943U) WHICH IN TURN DUE TO THE IMPACT INCH FORWARD AND REAR ENDED VEHICLE C(SLN5865Y). NO ONE WAS INJURED AT THAT POINT OF TIME.
