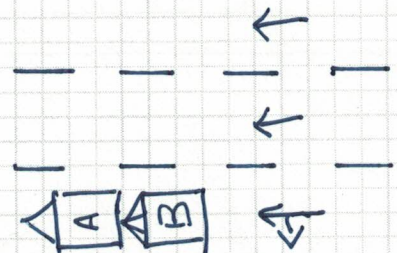

YIO CHU KANG RD



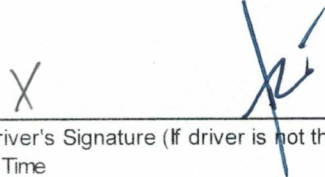
BEGONIA RR
