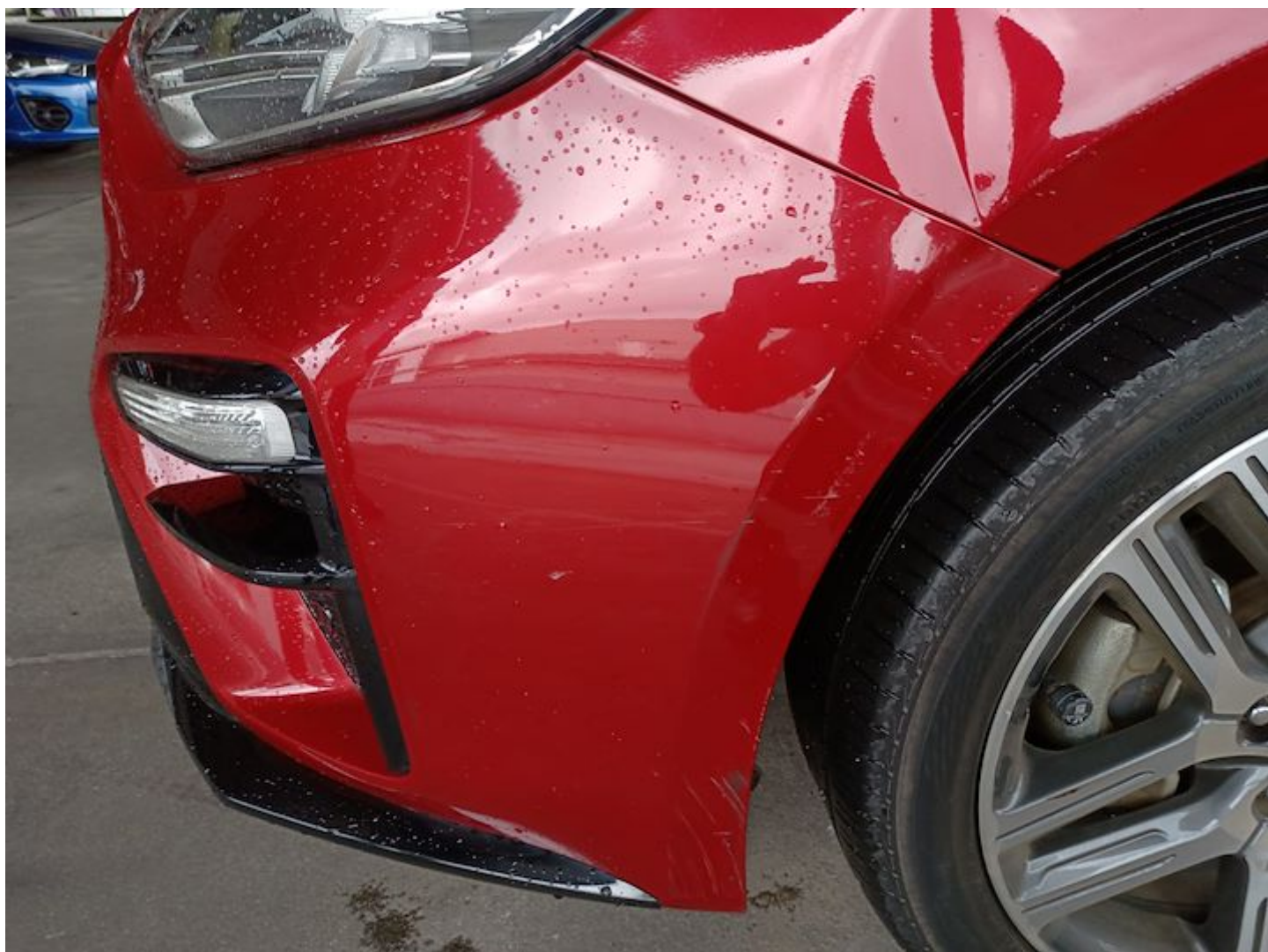


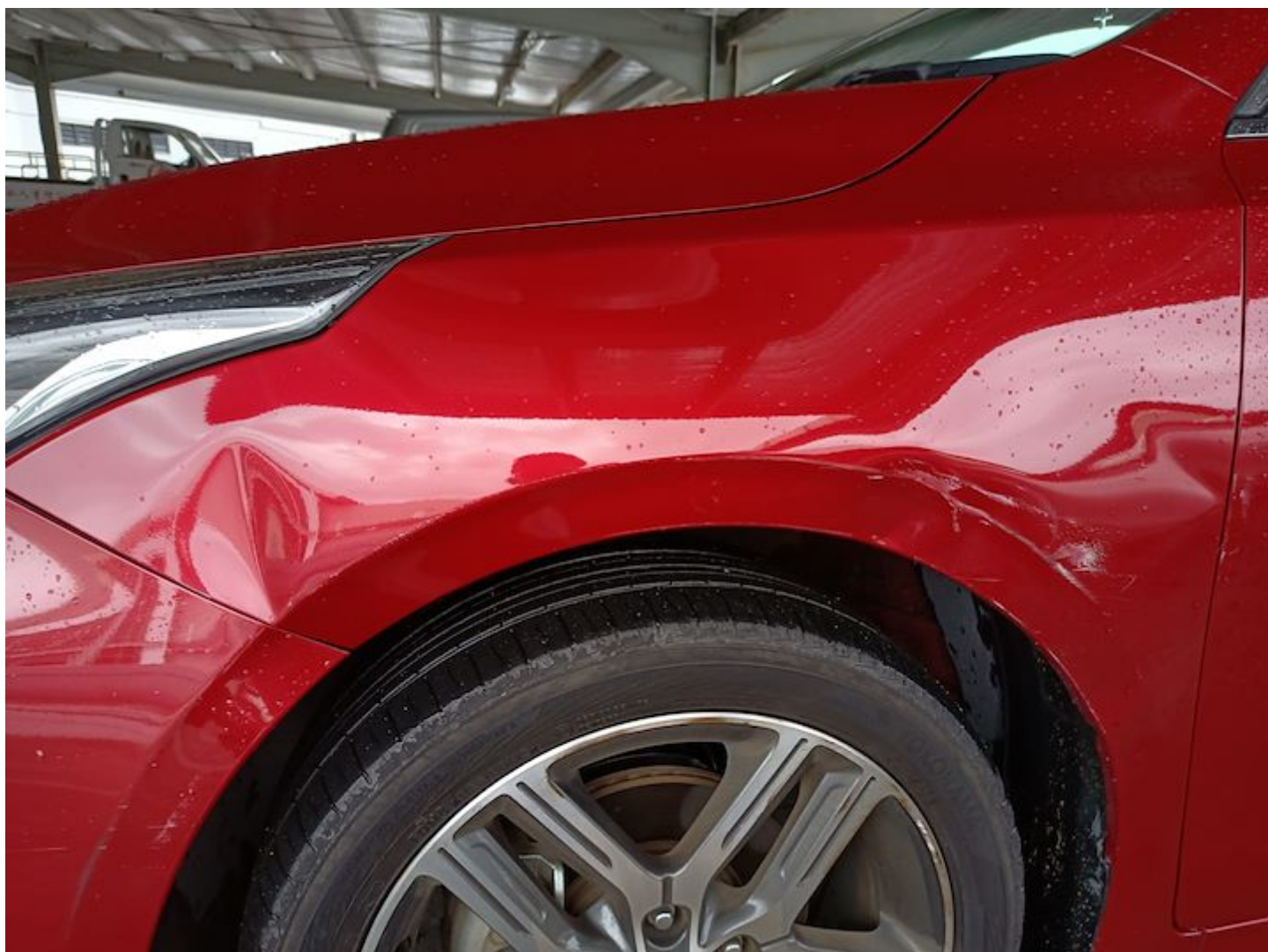






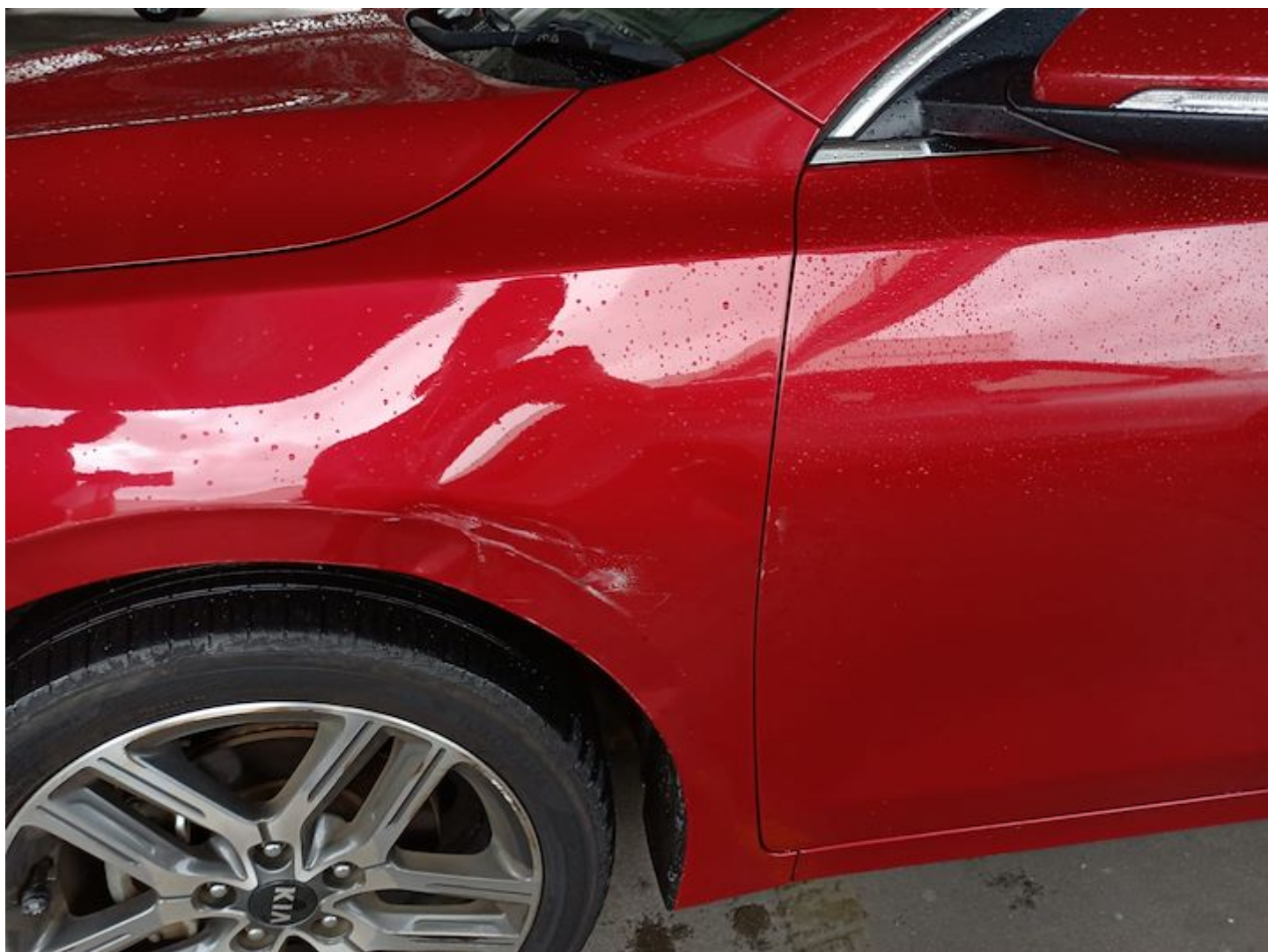

Brief Details.
