Thanks for the investigation report.

Moving on, I would like to share my thoughts on the incident....

- See the rear/front video provided with the accident report, I was driving into a junction when a black car came into my lane, so I stopped at the box junction at the traffic light. When the traffic light changed from yellow to red, I signalled left, checked that there were no cars and changed lane.
- Suddenly a red car speeded up from the other lane and hit my car on my left front side. The car did not stop immediately at the accident area, but just continued to drive off. I pressed the horn to stop the vehicle that hit my car.
- The driver then stopped at the left side of the road. I too stopped. A lady got out of the car and I asked for her IC, but she said that she did not bring it and that she is not the owner of the car. I gave her my mobile number and she whatsapp me the soft copy of her IC. I then took pictures of the damage to my car as well as the other car. There were dents/scratches on her car which the lady pointed to and said that it was not caused by my car.
- After she took a picture of my IC, both of us left. Once I reached home, I decided to write my accident report and looked at my whatsapp, I was shocked to realise that the driver had removed the details that she had whatsapp me and also blocked me. As I did not have her particulars accept her car registration plate number, I called the police station. After explaining the details to the police officer, I was advised to report the case as a hit and run.
- Accidents must be reported within 24 hours. See attach on 6 Sep, 'someone called me twice and put down the phone. I called the number and a lady answered. She referred to the accident and said that she wanted my car registration plate number. I asked her why she had removed the whatsapp messages she had sent on the day of the incident and also blocked me. I also told her that she would have my registration car plate as she too was taking pictures of the cars after the incident had happened. I did not give her my car registration plate.
- Later she sent me a message saying that I gave my car plate number and she will be claiming under a third party claim.
