On the stated date and time, I was travelling straight and within lane along the stated location along the left most lane of the expressway, I was riding my vehicle A, a motorbike bearing plate number FBN5073J. Suddenly vehicle B a lorry bearing plate number XE329S came out from the entrance leading into CTE and attempted to join the highway. He did not give way to me. The lorry suddenly filtered into my lane and I could not avoid in time, the side of his lorry caused a large impact to the left of my motorbike and this caused me to fall over to my right.
