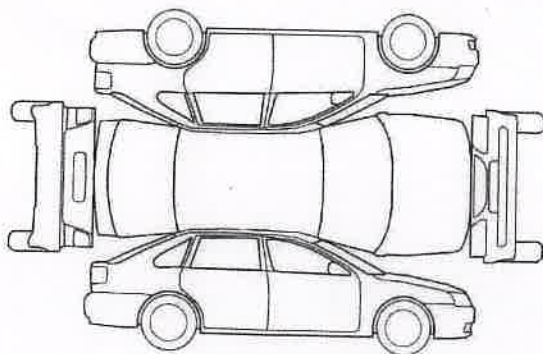




## TERMS & CONDITIONS
