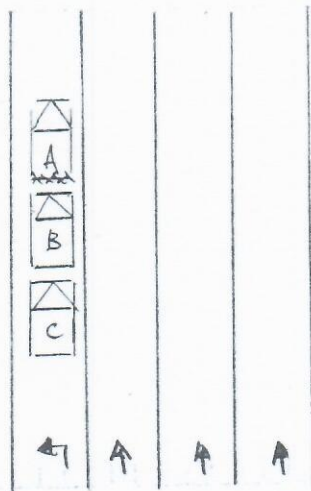

Sketch Plan




