## Brief Details.

On 07/09/2021 I was driving vehicle GBK5225D in the middle lane along Ang Mo Kio avenue 6 which is marked as both going straight and left turning. On my left, was a left turn only lane. Vehicle SH9077C was travelling on that lane. Towards the junction, both lanes were clearly divided by solid double white lines.

Before arriving at the junction, I had signalled my intention to turn left towards Ang Mo Kio avenue 8. There was a marking on the road to guide vehicles to turn into their respective lanes. I followed my marking and proceeded to make the left turn. While negotiating the bend towards Ang Mo Kio avenue 8, the front right side of vehicle SH9077C collided with the left side of my vehicle at 2.40pm. Due to the impact on the left side, my vehicle swerved towards the right and halted to a stop just ahead of the road divider.

The physical damages caused by the collision on GBK5225D are from the front left tyre with scratches extending to 3/4 of the left side of the vehicle. Additionally, in the impact caused me to swerve hard towards the right causing my left arm to involuntarily press on the horn. The sudden jerk from the impact caused me to immediately feel numbness in my fingers, strain and discomfort in various parts of my body.
