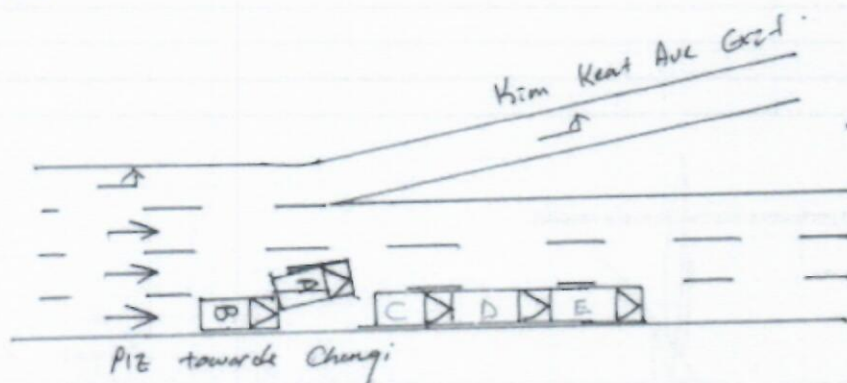

- (E) SNA 3986 P

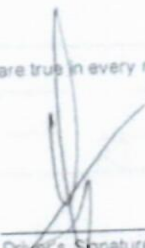
Describe Circumstances of the Accident

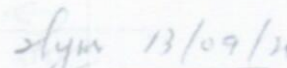

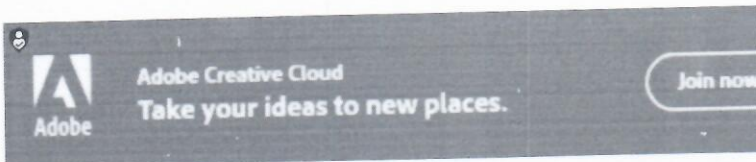
