Brief Details.

On 10/09/2021 at about 1735 hrs, I was driving my personal vehicle bearing vehicle registration number SJS9432K on the left lane along Yishun Central intending to turn left towards Yishun Central 2. I stopped behind another car before proceeding for the turn due to traffic ahead. While my vehicle was stationary, an ambulance bearing vehicle registration number QX1547E came from behind from the lane to my right at a high speed. As he was passing by my vehicle, he came slightly into my lane and collided onto the right side of my car. I horned at the driver to inform as he did not stop immediately.

Subsequently, I noticed the ambulance stopped ahead at the roadside after the junction to wait for me and I went there as well. Both of us alighted from our vehicles and I assess that he is not injured. We also exchanged our particulars. I asked the driver if he noticed my stationary vehicle on the left lane and why he did not turn on his siren but he did not reply. Both of us then took photos of the damages of both our vehicles and he issued me a letter by SCDF which is a correspondence notice that helps me to make a claim against the Government. He also advised me to lodge a Police Report to facilitate the process of claiming the damages. Both of us then left the scene subsequently.
