## Brief Details.

On the date, time and place mentioned, I was involved in a road traffic accident.

This was a drug operation and I was riding a motorcycle bearing FBL1365D. I was following a subject who was driving a car travelling along Buangkok Drive towards Buangkok Green(which was a 4 lanes traffic). I was lane splitting between lane 3 and 4.

As I was approaching the traffic light junction of Rivervale Link, I saw that the traffic light had turned red. I panicked and jammed my brakes so to avoid collision with the front motorcycle (FBL7945R) which is my colleague. Due to the excessive braking, my motorcycle skidded and hit the bike in front, while my body hit onto the rear wheels of the stationary van that was on the left lane.

Subsequently, I fell on the floor in pain and conveyed to Sengkang General Hospital.
