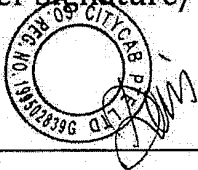
# LETTER OF AUTHORITY

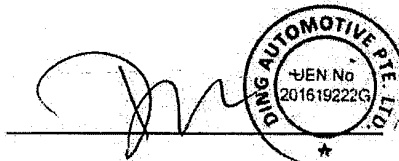
