

**Brief Details.**

On the 01/03/21, I have received a call from TP IO with regards to a case of traffic accident that I was not aware of. She mentioned that my vehicle had scratched onto another's vehicle and had lodged a police report thus they had send me a letter to make a police report. I then tried to find around my house and saw a letter from TP (ref: TP/IP/08129/2021). I do not have any impression of any incident that happened. I only recalled that day was the eve of Chinese New Year, I have drove my vehicle to the open carpark at Blk 835 Tampines St 83, parked into a lot and retrieve my food and subsequently left for work. The whole duration only took me around 5 minutes. I do not have any impression that my vehicle had come into contact with any other vehicle nor caused a scratch.

On the 18/02/21, my wife actually did informed me that there is a scratch of around 5 cm at the left rear passenger door. I do not know how this scratch comes about.

There is no in-car camera inside my vehicle.
