

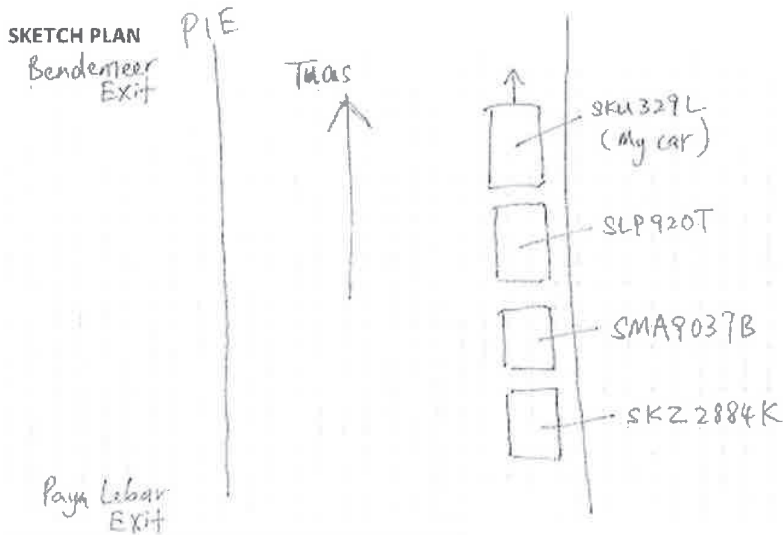

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On the morning of 17 Sep 2021, at around 7:23am, I was driving (SKU329L) on PIE (towards Tuas) on the far-right lane. The car in front of me stopped, so I braked and brought my car to a stop as well. At that point, my car was on the stretch of PIE between Paya Lebar Exit and Bendermeer Exit. After I stopped my car, seconds later, the car behind me ~~bum~~ knocked into my car. Upon exiting my car to check, I realised that it's a chain accident involving 4 cars. I believed the force of impact of the 4th car (SKZ2884K) pushed the 3rd and 2nd car forward, resulting in the 2nd car (SLP920T) knocking into my car. As far as I am aware, no one was injured in the accident. We ~~exchan~~ exchanged our licence details, took photos and left the scene thereafter.
