



Brief Details.

On 03/07/2021, at about 2140hrs, I was travelling in my company van, bearing registration plate number GBH5542D, along AYE towards Tuas direction. I was travelling on Lane 2 and was nearing to Clementi Ave 6 exit. It was raining and the floor was very wet. The vehicle in front of me was travelling too slowly due to the rain, so I decided to overtake him by using Lane 1. As I switched to Lane 1, there was another vehicle, bearing registration plate number SLC8993Z, also did a lane change after me. I just wanted to overtake the vehicle on the left, hence I only speed up a little. However the vehicle behind me was speeding up faster than me and collided onto the rear of my van before I could even switch back to Lane 2. I wanted to stop but I could not signal him to stop. I then switched on my hazard light but he ignored. The other vehicle immediately switched to Lane 2 and then Lane 3 to overtake from the left. After that he immediately overtook the vehicle in Lane 2 and me in Lane 1, and sped all the way. I thought he wanted to stop so I followed him and wanted to see his vehicle plate. I decided to give up following him as it was raining and it was also dangerous.

I did not spot any damage on my Van on the day itself. I only discovered some light scratches on the rear of my vehicle. There was no dents at all. There was no injuries.

My company has received a letter from TP with regards to the accident and has told me to lodge an accident report on the matter so I proceeded to do a report. The letter was also forwarded to me. The case is under IO Kaleswari A/P Palani. The report number given was TP/IP/32409/2021
