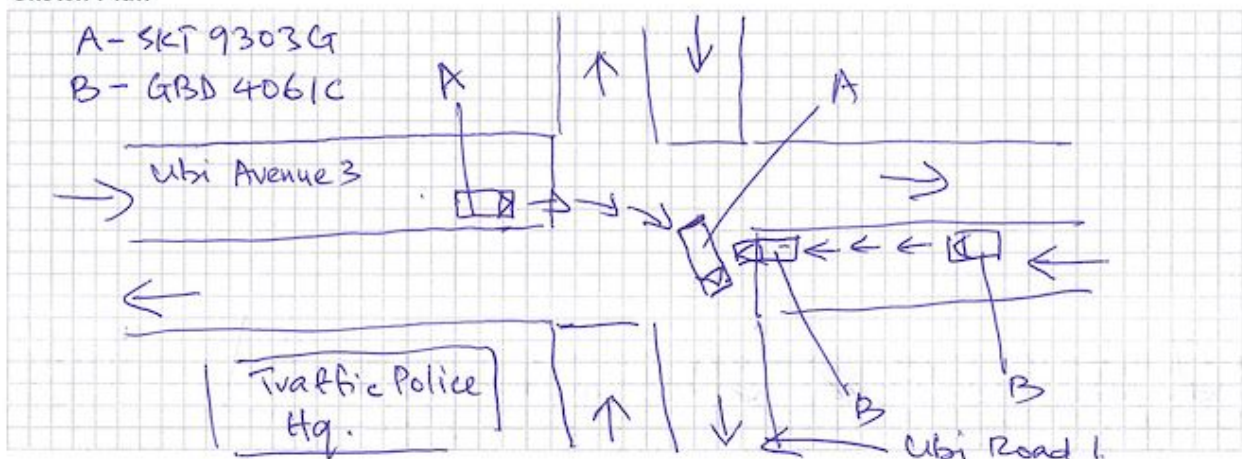

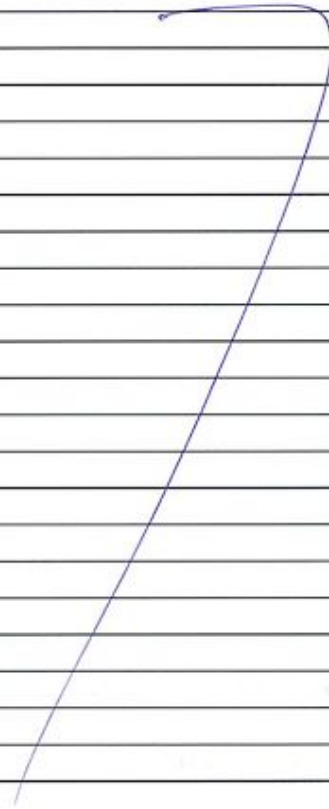
**Sketch Plan**
