

Describe Circumstances of the Accident

Around 8:05 am on 20 September 2021, I stopped at the traffic light at the junction of Grange Road and Napier Road. The traffic lights had turned red and my car was stationary. I had stopped for a few seconds and then my leg accidentally released from the brake pedal and I then gently hit into the Honda Odyssey car SLE 1784X (that was also had also stopped at the traffic light) in front of me. It was a gentle and minor touch to the rear of the Honda Odyssey.

The driver, Alessandra Nutter, was not carrying her NRIC nor driving licence. She messaged me her name and NRIC immediately at the accident location. I however, gave her a copy of my NRIC and asked her to report to the insurance.
