REQUEST FOR SINGLE JOINT EXPERT REPORT ON BJN 8800

We refer to the above matter wherein we act for the Defendant and Vision Law LLC act for the Plaintiff.

The Court has appointed you as the Single Joint Expert for this action to provide an independent assessment of the cost of repairs for motor vehicle number BJN 8800. Enclosed are copies of the following:-
