







The above mentioned patient was seen on 26th July 2020 at the Acute and Emergency Care Centre of Khoo Teck Puat Hospital. He was attended to by Dr Yi Wen Mathew Yeo, Dr Xue Bi May Na, Dr Michael Liu and Dr Kailing Adriel Rao.

Patient was involved in a road traffic accident on the same day. He was a motorcyclist and had collided with a taxi. He claimed to have flung onto the taxi's boot and possibly had lost consciousness. He was unable to recall the events of the accident. He was complaining of pain over his neck and left forearm.

On examination, he was alert. There was no head injury wound noted and no cervical spine tenderness on palpation. He was tender over the right paraspinal region. There was a superficial laceration wound noted over his inner lower lip. He had good air entry into his lungs with normal heart sounds on auscultation. His abdomen was soft and non-tender on palpation. His left forearm was swollen with an overlying superficial abrasion wound. Point of care ultrasound examination did not show any free intra-abdominal fluid.

XRays of his chest, pelvis, left elbow, left radius and ulna, and left wrist showed possible right lung contusion changes and displaced comminuted fracture of the left radius mid-shaft. A CT scan of his brain and cervical spine did not show any acute pathology. He was reviewed by the General and Orthopaedic Surgeons. Patient had declined an operation for his left arm. His left upper limb was placed into a backslab. He was treated with analgesia, antibiotic and a dose of anti-tetanus toxoid vaccine. He was admitted to the EDTU ward.

A repeat XRay of his chest the next morning confirmed that there was no lung contusion changes. He was eventually discharged on the 27th July 2020 with advice, drug prescription and 4 days of hospitalization leave certification. He was also referred to the Orthopaedics Fracture clinic to be reviewed as an outpatient.

Impression: Left Galleazi fracture and neck strain secondary road traffic accident.

# SPECIALIST MEDICAL REPORT FOR ARUNKUMAR RAMAMURTHY \$8260203H

The above mentioned patient first seen in our Specialist Outpatient Clinic (SOC) on 29/07/2020 as a referral from the Emergency Department. He was involved in a road traffic accident on 26/07/2020. Clinical examination revealed a deformity over the left forearm. There were no open wounds. There were no neurovascular deficits in his left upper limb. XRays showed a displaced left radial shaft fracture. In view of his injury, the patient was counselled for surgery with the risks versus benefits discussed extensively.

The patient underwent surgical fixation of his left radial shaft on 6/8/2020. The surgery was uneventful and he was discharged on 8/8/2020.

He was subsequently reviewed in the SOC. His surgical wound healed well and serial XRays showed progressive healing of the fracture. His range of motion of his elbow, in particular, pronation and supination was satisfactory. The XRays performed on 23/7/21 showed complete healing of his fracture.

During the last review in the SOC on 11/8/21, the patient claimed he was well. He had resumed his work 4 months after the accident. He claimed that he has no problems in the course of his work. He has resumed sporting activities, notably weights training in the gym approximately 3 times a week. He does not have issues with his activities of daily living, and is back to riding his motorcycle. Clinical examination showed:

Left elbow range of motion: Flexion-extension arc 0 to 150 degrees Pronation 0 to 80 degrees Supination 0 to 75 degrees


