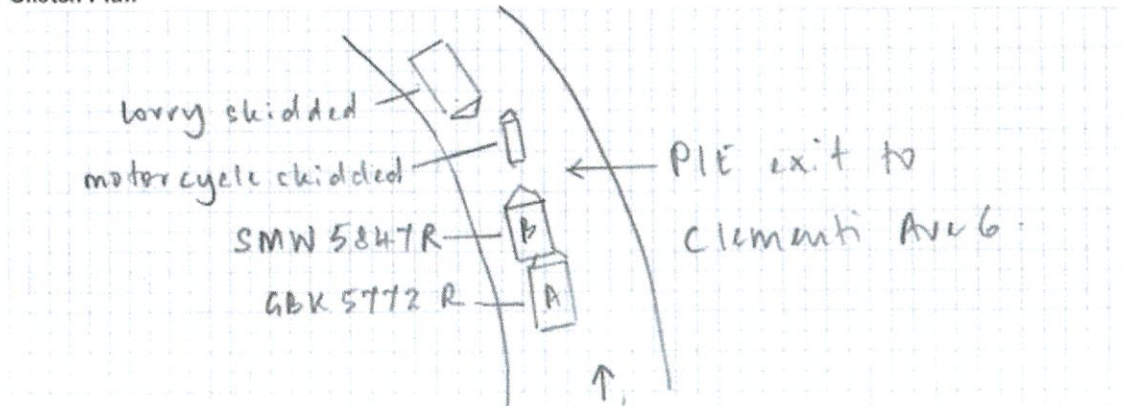

I immediately applied my brake but unable to stop in time due to road surface wet (after rain) and slippery, collided into veh B rear. After the accident, I came out and saw a motorcycle and a lorry had both self skidded and there was no accident between them and veh B. Veh B had stopped when she saw the motorcycle fell on the road.
