I was riding on the left most lane, middle of the lane. PIE heading towards Changi, Paya Lebar exit. I saw SHB4492G weaving left and right on the second lane. I horned a few times to warn the taxi. But suddenly, taxi change lane without signal and hit onto me. The 4 AETOS passengers in SHB4492G also heard the horn but the driver still change lane. I was conveyed by ambulance and hospitalized for 1 day. Given 8 days MC, with some follow up treatments.
