Thank you for your email.

We deeply understand where you are coming from.

1. We, our end here does only handle property damage but apologies that Body injury claim to don't handle.
2. As this is only based on verbal report and sketch, thus, to allow us to investigate the matter, we do need concrete evidence like traffic police investigation result and/or accident video footage. However, based on what we know here, you have been charged by traffic police in careless driving causing hurt. Therefore, liability is not in our favour whereby traffic police has come to a final investigation in this matter.
3. Based on your scene photo attached, the head of your vehicle was eventually encroaching into Third Party Lane as well, whereby Third-Party vehicle indeed also slightly out of his lane.

In view of above, we will need to proceed with the third-party settlement at our very best in reducing all cost in the property damage.

Dear Sir

I read that your investigation have been completed. However I have not been called up to present my views or to show the site photos I have taken which may be useful to you.

Nevertheless please refer to your above report regarding the accident which happened on 23/9/2021 between car SDG7999M which I was driving and another car SMV3600D.

The location was at junction of Marine Parade Road/Still Road South, turning towards ECP.

The other car SMV3600D was on lane 1, which is a turning lane while mine was on lane 2, which is a turning and straight through lane.

Please see attachment in PDF format which may shed further information if you need them.

1) A sketch of the accident site/junction.

2) photo 1-A close up view of the 2 vehicles-please note the left wheels of the other car were sitting on the extreme left lane marking, thus the car side body was encroaching onto my lane 2.

Please note my car had moved fwd out of traffic junction by about a car length, and that was when I had to maneuver into the centre waiting spot for traffic light to turn green before proceeding to ECP.

Please note the other car had already left the traffic junction, but the position of that car was still hugging to the extreme left lane marker. In my opinion if that car should want to turn right, the driver should start maneuvering albeit slowly and carefully towards the right as his lane is a turning lane.

My comments-that car was in a critical position and accident is inevitable and in this case grazed my car.

-I think that car may have driven inappropriately on the wrong lane in the first instant.

-I feel any like minded driver should drive slowly and cautiously in that traffic junction.

-of course I leave the final judgement to the traffic experts.

3) photo 2 - back view-Please note again it clearly showed that, that car was out of its regulated lane.

-The man on the right was the driver, young and very healthy looking and appears to be unaffected by the incident.

4) photo 3 -Front view- Please note again it clearly showed that, that car was out of its regulated lane compared to all the other cars behind it. The clear distance between the left road side kerb and that car SMV3600D was about 2 feet. That man standing there was the owner and driver, appeared very confident that he had the right of way.

Concluding message

A point of interest was that there was a police patrol car in the vicinity at that time. The officer came over to both cars and checked with both drivers whether any one was hurt and whether any public properties were damaged. Since there were no injuries the officer directed both cars to move to the roadside next to Tao Nan school to continue our changing of particulars.

I was surprised to know sometime later that, that driver had been granted 3 days of MC.

By right its me or my wife sitting beside me should have sought medical attention, because that car grazed directly on the door where I was sitting.

I was flabbergasted when I read in the Traffic Police Report that my offence was quote "Careless Driving Causing Hurt ". Doubt should be given in a situation when in a slow moving and turning situation the driver can get hurt when brake is applied. Perhaps for drivers with pre-existing medical impairment like what we read about in covid-

19 cases of unvaccinated citizens ?

Thank you for your understanding. I hope justice prevails.
