
The Company Warranty

Should there be a need for The Renter to leave the rented vehicle at The Company workshop for repair more than 1 working day, The Company shall not / will not issue a replacement vehicle. Should there be any unforeseen circumstances which The Renter is unable to bring the Rental Vehicle back for return on the agreed Return Date, a towing service can be arranged. The towing service is available at \$\$80.

Indemnity

Regardless of Insurance coverage, Renter shall fully indemnify The Company for any loss, damage and legal actions including reasonable attorney's fees that The Company suffers due to Renter's use of vehicle during the term of this Agreement, including but not limited to, damage to the vehicle, damage to the property of others, injury to Renter, and injury to others. The Renter will bear whole cost of the claim and repair costs of the vehicle rented and other third part claims and In the event of accident, the Renter will bear the cost of Excess (Section 1) S\$2,500 / Excess (Section 2) S\$2,000. (Final decision will be determined by the Company) This provision survives the termination of this Agreement.

If the vehicle is involved in an accident, the Renter has to inform The Company, the Police or other relevant authorities in writing of the accident and shall also notify The Company in respect of any claim arising thereafter from the accident. No admission compromise offer payment or indemnity shall be made by the Renter without The Company's consent in writing. The Renter shall render such information and assistance in connection with the accident as The Company or its insurers may require.

Liabilities / Fines / Damage to vehicle / Lost of vehicle

Renter shall be solely responsible for and hold The Company fully indemnified against all claims, demands, liabilities, losses, damages, proceedings costs, expenses, fines, penalties and liabilities imposed on The Company or arising in respect of any on compliance or contravention of any transport, traffic or other law or regulation, together with the cost and expense including but without limitation costs on a full indemnity basis relating thereto incurred by The Company. The Renter shall bear the cost of the repair, loss of use or rectification of any damages caused to the vehicle while in the possession of the Renter. If the agreed rental vehicle is damaged to the extend that it is deemed by The Company to be a total loss, The Renter shall pay The Company the cost of obtaining a replacement for the vehicle and shall also compensate The Company the loss of use of the vehicle during the period of reinstatement or repairs. The Renter shall also compensate the Company all towing, storage and administrative

charges. If the vehicle is stolen or otherwise lost whilst it is in the possession of the Renter, the Renter shall compensate The Company the cost of obtaining a replacement vehicle and for loss of use for the period required to obtain the replacement.

Restriction on use

The Renter covenants to use the vehicle only for Lawful and Legitimate purposes and not to use the vehicle for any unlawful purpose activity. Vehicle is restricted to Singapore use only. Renter shall not take the said vehicle outside mainland of Singapore. Failure to comply with this term may entail serious consequence and The Renter shall assumed personal and full responsibility. In event of the said vehicle being damaged, confiscated, forfeited or seized as result thereof, the Renter shall indemnify The Company for any all the losses incurred including the full value of the said vehicle. The Company shall not be responsible for any liability, claims and injuries or otherwise in connection with any accident death or other losses arising from the use of the vehicle. The Renter agrees that The Company shall not be responsible for any liability, claim, loss damage or press of any kind or nature caused directly or indirectly by the vehicle or its use. The Security Deposit will be forfeited if The Hirer exit Singapore with the vehicle without written consent by The Company. The Company reserve the rights to recover the vehicle from The Renter and all costs of recovering the vehicle will be payable by The Renter.

Other Conditions

The Company reserve the rights to terminate the rental without any liability should the Renter failed to make the monthly rental prepayment in advance. The Company forfeit the security deposit placed for each vehicle. Upon termination / end of the Rental Agreement, the Renter shall return the vehicle to the Company. The returned vehicle should be repaired to its original condition before returning to The Company. The Company reserve the rights to repair the vehicle to its original condition and offset the repair fees from the security deposit before refunding (if any), the balance amount to the Renter. The Renter required to return the vehicle key in the same condition when he / she rented from The Company. Lost or damage of the key will be chargeable. If the vehicle is found to be ridden by anyone other than The Rental named in the Rental Agreement, the vehicle will be seized by The Company without any refund. If The Renter lend the vehicle to a third party without notification to The Company, and the vehicle is involved in an accident, The Renter will bear the whole cost of the claim and repair costs of the vehicle rented and other third party claims. No repair is to be done without The Company approval. If the Renter is caught repairing the vehicle at any workshop unauthorized by The Company, compensation of \$\$2,000.00 is payable to The Company. Any damage to the vehicle will be charged to The Renter accordingly to the repair costs to rectify the vehicle to the same condition as it was at the start of the rental. All charges and amounts due which are not paid when due shall bear an interest of 2% per month until it is paid.

This agreement shall be governed by and constructed in accordance with the laws of the Republic of Singapore and the parties agree to submit to the jurisdiction of the Courts of the Republic of Singapore. I / We agree to the above-mentioned terms and conditions.
