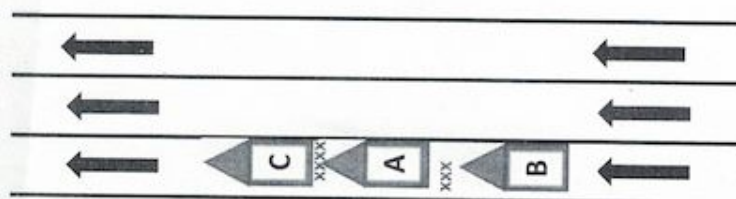

Brief Details.

On 26th Sept 2021, Sunday around 1715 hrs. I was travelling along Seletar West Link, toward Seletar Dam, going to Yishun for a work appt. As i was approaching to the traffic light, turning left onto Seletar dam, the traffic was moderate to heavy. The traffic is a usual bottle neck for vehicle turning left. My car was stationary behind a Volkswagen, SMR 912 U. Both of us has stopped due to the traffic build up before the traffic junction. Suddenly, I experienced a loud bang and collision from a van on my rear, GBG 3342H. It happened so sudden that my car moves forward and knocked into the car in front. I'm the second car caught in between SMR 912U and GBG 3342H. My car was rear ended by the oncoming van GBG 3342H while stopped stationary awaiting the traffic light. I am alone in my vehicle and i have checked if the driver in the front SMR912U is fine. We exchanged contact, took the photo of the accident scene and left.

I suffered a moderate whiplash on my neck, shoulder, and lower back. I have consulted my GP and given 3 days of medical leaves. 27th - 29th Sept.
