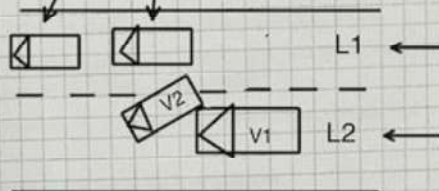

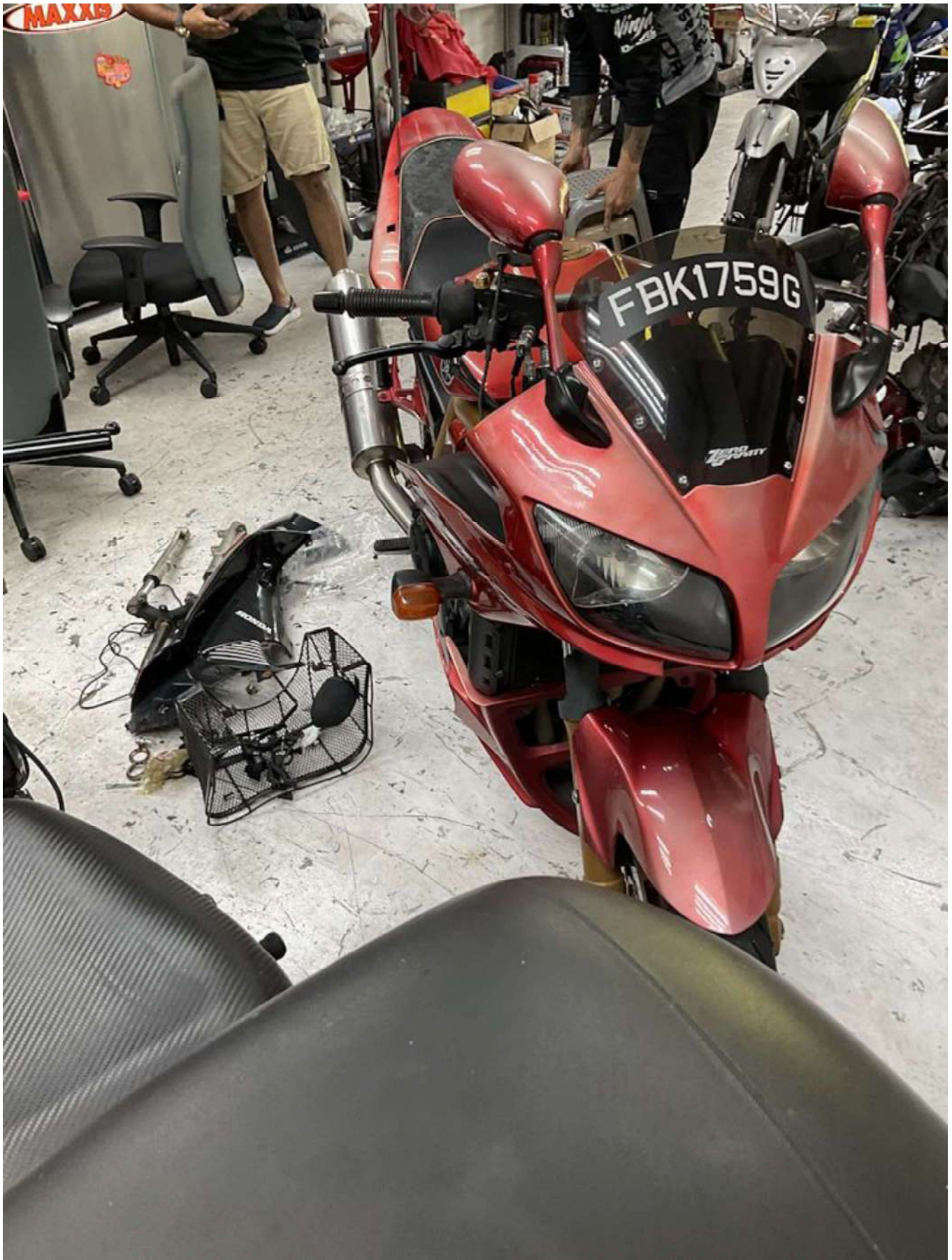

#### Brief Details.

On 21.09.2021 at about 1700hrs, I was riding a rental motorcycle, FBK1759G along Bukit Batok East Ave 3 towards Bukit Batok. It was a two lanes road and I was riding on the left.

There was a vehicle, SLT641C driving on the right lane. He made a sudden lane change without signaling. The driver hit onto the front wheel of the motorcycle. As a result, I was not able to control the said motorcycle. I fell together with the motorcycle. The motorcycle skidded and hit the rear middle bumper.

I immediately called the rental company and the motorcycle was towed to their workshop. The damages of the rental motorcycle were dented on the tank of motorcycle, scratches and paint chipped off on the left hand side.

Subsequently, the driver came down from his vehicle to render help. The damages of the other vehicle was a slight dent on the rear left and rear centre bumper.

I believe a passer by had assisted to call for police and ambulance. However, I did not wish to be conveyed as I was still able to walk. However, I went to visit a clinic on 22.09.2021 and received a 5 days MC.
