SKETCH PLAN

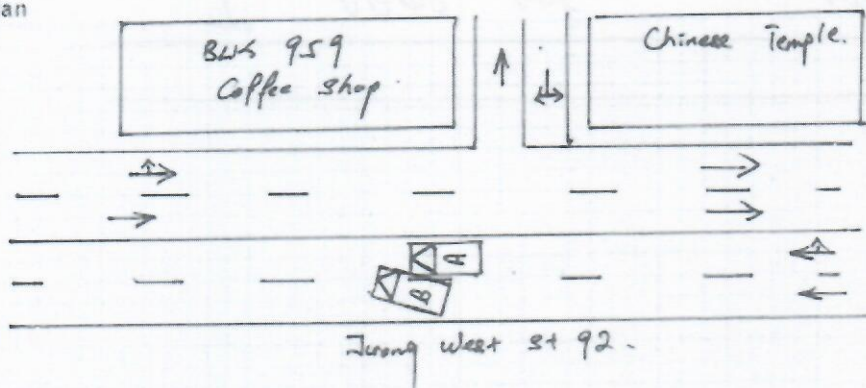
