

Police a non-injury traffic accident which occurred at Blk 108 Tampines Street 11 open carpark on 15/09/2021 at 7.45pm involving the following vehicles;

- A) SBM78J – Gold Renault Megane
- B) SME7078A – Black Toyota

1 On 15/09/2021 at 7.45pm, I was driving my vehicle (Vehicle A) out from a parking lot at the open carpark beside Blk 108 Tampines Street 11. Vehicle B, which was driving straight without its headlights on, hit onto the right front of my vehicle. The driver of Vehicle B and I alighted from our vehicles and exchanged particulars once we assessed that nobody was injured. Vehicle B's driver admitted that it was his mistake and we agreed to report the matter to our insurance. We then drove off. No Police or ambulance was at scene.
