
(a) My insurer, my workshop and the General Insurance Association of Singapore ("GIA") may/are permitted to collect, use, disclose and/or process my personal data/personal information set out in this [form] and any other personal information provided by me or possessed by my insurer (collectively the "Personal Information") and disclose and transfer such Personal Information to all insurer(s) who have insured vehicle(s) involved in this accident (all insurer(s) who have insured vehicle(s) involved in this accident shall be collectively referred to as the "Insurers"), the Insurers' lawyers/law firms, the Monetary Authority of Singapore and any relevant government agency/authority (such as the police), for the purpose(s) of:

- (i) processing, handling and/or dealing with my claims including the settlement of the claims and any necessary investigations relating to the claims;
 - (ii) investigating the accident and/or my claims;
 - (iii) carrying out and/or dealing with my instructions or responding to any enquiries by me;
 - (iv) administering my claims (including the mailing of correspondence, statements, invoices, reports or notices to me, which could involve disclosure of certain personal data about me to bring about delivery of the same as well as on the external cover of envelopes/mail packages); and/or

Describe Circumstances of the Accident

On 29/09/21 @ around 07:15 hrs, I was travelling along Bungkok Green (towards CTE) on lane 3. Two vehicle (SJC 8335Y) in front of me suddenly jammed his brake & took a legal right turn towards Bungkok Drive direction.

The vehicle (SSM 5771M) in front of me took an E-brake at the junction as a result, I couldn't stop on time & bumped onto him. Following which, a third vehicle (SS SLE 7724A), also couldn't stop on time & bumped onto my vehicle.

Of note, we were all travelling within to allowable speed limit of 21.50 following a proper safe distancing (see enclosed video cam footage).
