**Brief details.**

I was travelling along Lane 1 on Tuas South Ave 5 at an approximate speed of 65km/h when my motorcycle (FBF7798E) crashed into the forward part of SMRT taxi (SHV5685K). The vehicle was in lane 2/3 on the same directional road and attempted to make an illegal u-turn onto the opposite traffic lanes by cutting across the chevron markings. The road ahead of me was clear on both directions prior to collision when his vehicle suddenly appeared in front of me and I could not stop in time. I do not remember events after the collision as I've passed out and only regained consciousness in the ambulance.
