We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.

We have received a claim from GBL5026G against your insurance policy.

Based on the accident report and accident scenario, we are of the view that liability is not in your favour as you reversed and collided onto third party parked vehicle.

We understand that you would like to know the repair cost on third party vehicle. Our surveyor had physically conducted survey to third party vehicle and is in the view that the damages sustained to the Third Party vehicle is consistent to the nature of accident as reported. The adjusted repair cost to third party vehicle is at \$1,369.00(before GST) with 2 repair days. The repair cost included the replacement of front bumper, front right headlamp garnish & labour charges. We attached here with the damage photos during our inspection for your easy reference.

The final claim amount including repair cost, rental fee & disbursement will be at \$1,680.83.

We will therefore proceed to negotiate for an amicable settlement with the Third Party. Should you however wish to further discuss on the matter prior to our negotiations and settlement, please contact us within 07 days from the date of this letter.

Please note that your No-Claim Discount (NCD) (if any) will be affected upon next renewal due to this Third-Party claim. However, if your policy has a NCD protector feature, it will be deemed utilized for this claim and your NCD will be protected.
