Please be informed that OI has reported. Please refer to the below OI's sketch plan and statement.

#### Brief Details

On 26/09/2021 at about 2215hrs, I was travelling along Jurong Townhall Road towards Jurong East Ave 1, on my company's van bearing registration, GBK533K (Nissan, Grey) together with my wife and son on the extreme left lane, as I wanted to turn left into Jurong East Ave 1. I noticed that there was a motorcycle in front of my vehicle bearing registration, FZ2045A. As were approaching the zebra crossing, the motorcycle in front stopped suddenly, and as such I was not able to stop on time. The front of my vehicle made contact with the back of the motorcycle. The rider then tried to control the motorcycle to prevent it from falling over but to no avail, and fell to the side together with the motorcycle.

I went down my vehicle to make a check on the rider, and was informed by him that he does not require ambulance assistance and that he was okay with private settlement. We exchanged particulars subsequently. When I asked why did he made the sudden stop, he informed me that he saw a cyclist suddenly crossing the zebra crossing and as such to prevent accident, made a sudden stop. There was no pillion at that point of time.

During the incident, my company's van sustained the following damage to the front left upper panel of the vehicle (Dents). The motorcycle's box, was dislodged from the motorcycle.

To my knowledge, the rider was not injured. There was also no damage to any government property, no Police or ambulance attended to our incident.
