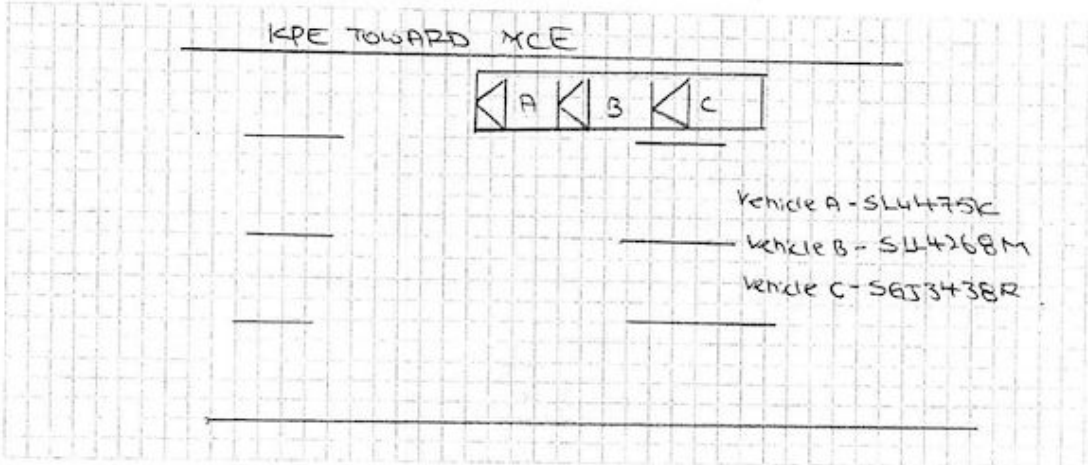

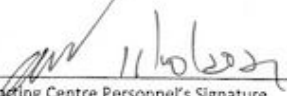
Vehicle ahead me stop and my vehicle stop too. suddenly I felt an impact on my vehicle. I came down and check it was a 3 car chain collision.
