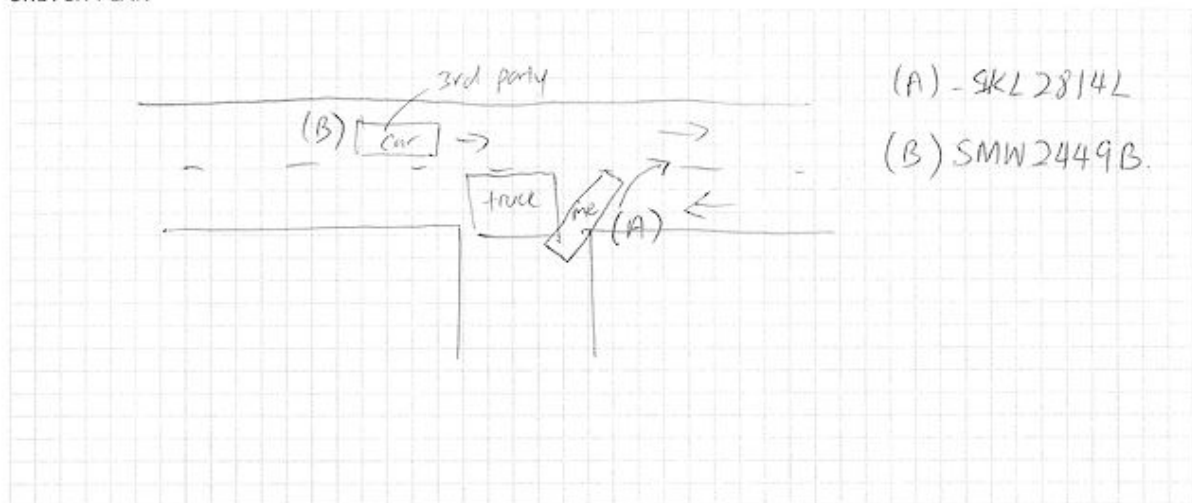

Happened in T junction. ~~the~~ Truck was blocking T junction.

I had to turn right, however could only inch out due to visibility issues because the truck was blocking. Car B was driving straight & could not stop in time when he saw my car inching out. I could not see any incoming car due to poor visibility from ~~truck~~ blocking.
