Brief Details.

On 30/09/2021, at 1815hrs i was riding along new upper changi road, at the lane 1. Meanwhile, car SMD899Z, black audi, was exiting bedok central carpark exit. Noticing this, i had slowed my motorbike down, however, understood that there was a double white line on my left (new upper changi road, east bound, lane 1). Vehicle SMD899Z had undertaken an illegal manoeuvre, cutting across all 3 lanes along new upper changi road (east bound) in an attempt to utilize the u-turn. In order to avoid the collision, i did a jam brake and my motorcycle skidded. I was then fall off from my motorcycle.

The male driver then stop his vehicle in the u turn road and came over to assist me. He then apologise to me. Subsequently ambulance and traffic police came. I was convey to CGH and was given 3 days of MC. Till now i am unable to access the damage of my motorcycle as my motorcycle was towed back to TP.
